In the event that we (I) cannot be contacted through the contact information provided on this form in a reasonable length of time equal to the severity of the emergency situation, we (I) authorize an adult, in whose care the minor has been entrusted, to consent to any formally requested X-ray examination, anesthetic, medical, surgical or dental diagnosis or treatment, and hospital care, to be rendered to the minor under the general or special supervision and on the advice of any physician or dentist licensed under the provisions of the Medical Practice Act on the medical staff of a licensed hospital, whether such diagnosis or treatment is rendered at the office of said physician, or at said hospital. The undersigned shall be liable and agree(s) to pay all costs and expenses incurred in connection with such medical and dental services rendered to the aforementioned child pursuant to this authorization.

Further, should it be necessary for the participant to return home due to medical reasons, disciplinary action or otherwise, we (I) hereby assume all transportation costs. The undersigned further hereby agree to hold harmless and indemnify said church, youth centre, its directors, employees and agents, for any liability sustained by said church as the result of the negligent, willful or intentional acts of said participant, including expenses incurred attendant thereto.

I/we also give consent to the Ark Youth Centre and First Baptist Church to use pictures and/or video of this student, if taken while participating in these group activities, for promotional purposes with the understanding that only appropriate and pertinent photographs will be used.

The undersigned does also hereby give permission for our (my) child to ride in any vehicle designated by the adult in whose care the minor has been entrusted while attending and participating in activities sponsored by the Ark Youth Centre and First Baptist Church, Penticton. I/we understand that students may leave the Ark/Church building and property and not return.
